

## Filling in your V70 form.

**NOTE! This form is for and exchange of tax and not application for tax. This form cannot be used if you pay by direct debit**

See DVLA forms – V10 (PLG) or V85 (HGV/PHGV)

*\* Only details listed below to be completed on form*

Section 1 – your full contact detail.

Section 2

2.1 – Registration number, Make + model as shown on plate or logbook

2.2 – Tax Class.

**Either** PHGV (motorhome) or HGV (horsebox or goods) for a vehicle over 3500kg  
**Or** PLG if a vehicle of any type at or under 3500kg

2.3

**Number of axles box = 2**

**Revenue weight** you have changed to e.g. 3500kg/3700/3850 etc.

2.4 – Fuel Type

Diesel, Petrol or Heavy oil

2.7 – Date of Change box

Complete with date you are applying for change.

## Section 3

**If changing** from PLG to PHGV or HGV you are likely to be in credit and this amount can be left blank and you should circle "I claim a refund of duty"

**If changing** from HGV/PHGV down to PLG, you are likely to be owing DVLA an amount and this must be entered in the box shown.  
- See calculation box below.

Please be aware that the calculation is a guide only and may not reflect the current vehicle TAX amounts.

This should be checked on DVLA form V149

**Sign and date** – sign and date for date applying

Going from HGV/PHGV - £171 tax / 12 months or £94.05 / 6 month, down to PLG - £360 / 12 months or £198 / 6 months

Amount owing based on 12 or 6 month tax term as follows

If taxed for 12 mnth.

e.g. £189 / 12 = £15.75/month

If taxed for 6 months

£103.95 / 6 = £17.33 /month

Multiply this figure by the amount of months remaining, including the month you're in, to find the amount owing.

e.g. £15.75 x 4 months = £63.00 owing.
